Annex 2.0 Recent ENPE activities, forthcoming activities and publications

ENPE Annual conference

Our 2019 annual conference will be held jointly with EUROJUST in The Hague, Netherlands at the EUROJUST Headquarters from the 28 and 30 October 2019. All ENPE members are invited to attend and some travel and subsistence assistance may be available. We will also be holding our general meeting (AGM) on the 29 October at the same venue. Please keep in touch with us for updates.

LIFE-ENPE Working Group activities

ENPE is running a 5 year LIFE-funded project to help meet our aim. The LIFE-ENPE project (LIFE GIE/UK/000043), under Action B2, requires that four Working Groups are convened to improve the prosecution of Environmental Crime in the following areas: Wildlife (WG1); Waste (WG2); Air Pollution (WG3) and Sanctioning, Prosecution & Judicial Practice (WG4). All groups are preparing their Second Stage Interim reports, including training plans and materials where available, for sharing by the end of April 2019.

Working Group 1 (Wildlife Crimes), chaired by ENPE Secretary Lars Magnusson, organised and hosted a training workshop together with the UNEP Convention on Migratory Species in Segovia, Spain from 09-11 May 2018. Working Group 2 (Waste Crimes), chaired by ENPE Director Rob de Rijck, recently completed some animated training on the EU Waste Shipment Regulations and together with Working Group 3 (Air Pollution), hosted a joint training workshop in Cyprus in March 2019. Working Group 4 (Sanctioning, Prosecution and Judicial Practice), chaired by Carole Billiet has released a Guidance document to assist in the harmonisation of applying sanctions to environmental crimes and will provide more details on outputs in the Second State interim report.
